COVID RELIEF FUND

One of the core cooperative principles is concern for community. To help members directly affected by COVID-19, the High Plains Power Board of Directors voted on establishing a COVID Relief Fund. Application forms are available, on the website or call and request a form to be mailed to you. This program has limited funds and is on a first come first served basis.

We understand that in these uncertain times it is difficult and frustrating. It is imperative that if you are having difficulty paying your electric bill, please call High Plains Power and speak to one of our Customer Service Representatives. Let them know of your situation and we will strive to work out an individual plan with you.

Unfortunately, another problem during this global pandemic is scammers. Scammers target utility

customers because consumers are understandably anxious with threat of disruption to their utility service. New products and services in the energy industry provide an opening for scammers and pop-up companies to provide misleading information or shoddy products and services to obtain your money.

AVOID PHONE SCAMS

A common phone scam typically begins with a phone number that appears to be from a valid utility company. The individual or company will claim you have a past due account and threaten to disconnect service or take legal action. These scammers will typically demand that you use a prepaid debit card or money order, often within a very short, urgent time frame, to pay the past due amount. High Plains Power does not demand

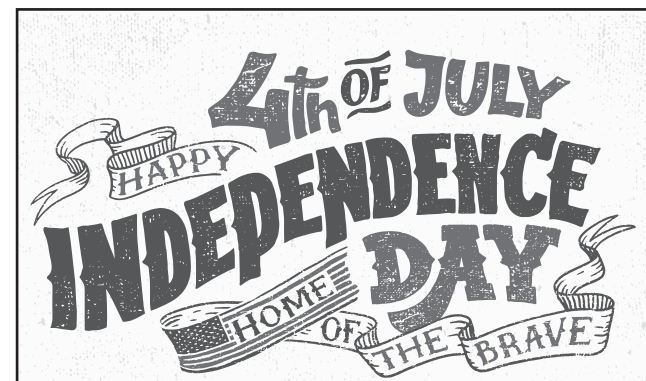

money with a short, urgent time frame.

Never give your banking or personal information over the phone to someone you did not call. If you have a question or concern about your energy bill, call us directly 307-856-9426 or 800-445-0613.

With typical spring and early summer weather we have experienced a lot of wind and some lightning storms. This has caused some power interruptions. A good share of the outage issues during the windstorms, is tree branches in or near the power lines. It is important to keep trees away from the lines. We have a tree service contractor hired to clear our right-of-way to keep service more reliable and safer.

This edition of the newsletter has a list of names that had capital credit refund checks issued to them in December 2019 but were returned to High Plains Power due to an insufficient mailing address or they remain uncashed. High Plains mailed capital credit checks to those who were members from 2003-2006 reflecting their contribution of capital to and ownership of, the cooperative during those years. Remember, if you purchased electricity during the years being retired, then you are entitled to a capital credit refund, even if you move out the High Plains Power's service area. That is why it is important to keep us updated of any address changes.

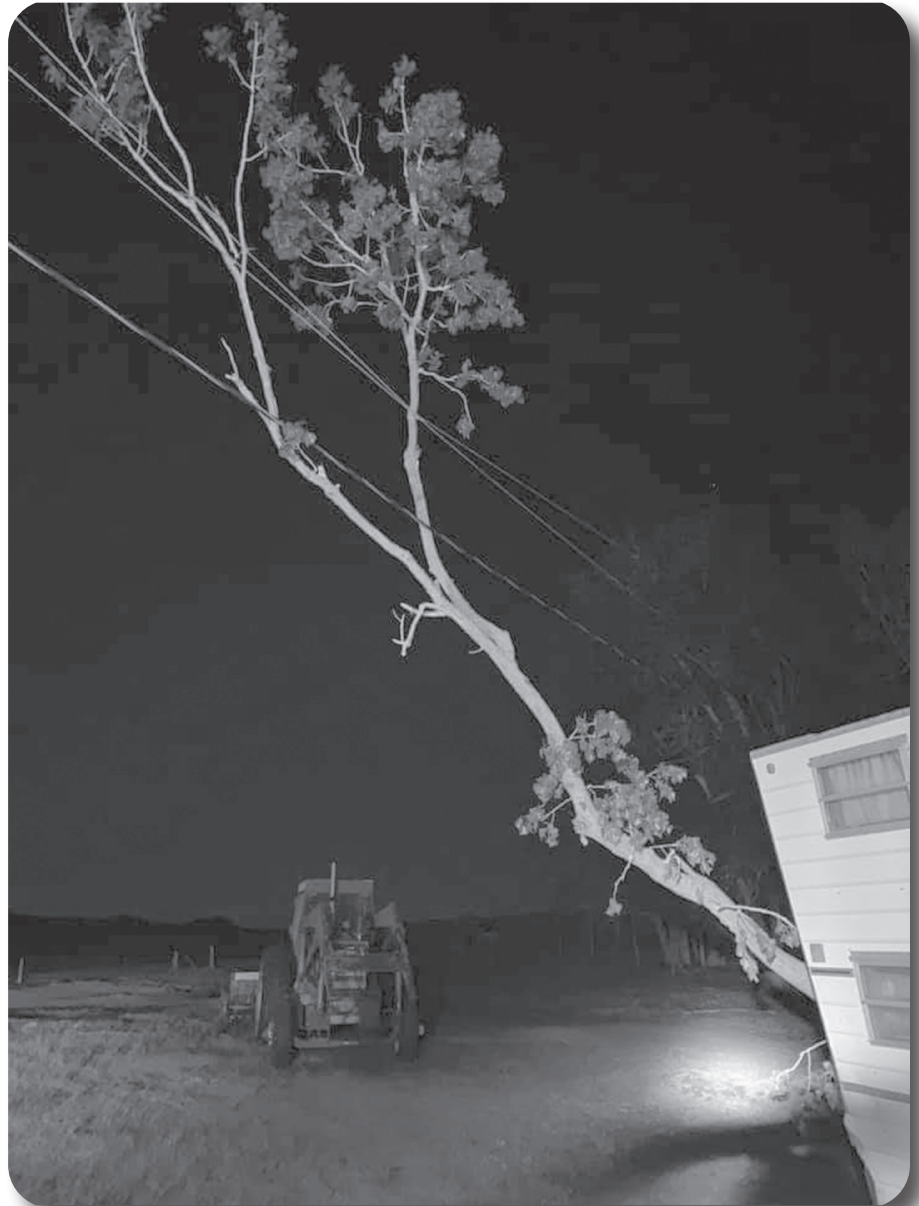
