A By-law committee comprised of 6 board members, legal counsel and I had monthly meetings since April to review and revise the By-laws. The regulations have not been examined in a material way since 1997, when Riverton Valley Electric and Hot Springs Rural Electric merged. The advanced metering infrastructure project is still proceeding in a positive direction. We have been very pleased with the outcome of the information we have received for the installation thus far. We have been getting real time meter readings and have been getting information when an outage occurs. We can see (real-time) which meters are out of power and are able to respond in a timelier manner. I have mentioned the benefits before, but we are experiencing it first hand as more and more meters are installed. One of the biggest benefits is the cost savings for you as a member. Remote meter reading generates more timely, accurate bills and eliminates the need for manual truck rolls and labor to read meters. Also, connections and disconnections can be accomplished remotely. We have also been able to detect meter tampering or theft from the system. In the Riverton area, we are going to start with those services being fed from Medow Substation. We should be receiving equipment in February.

WHO IS ELIGIBLE?

Applicants must be graduating high school seniors planning to enroll as fulltime students in the 2019 fall semester at any university, college or certified vocational/technical school. 

Qualifications to be Director

A nominee or candidate for the director of High Plains must be a member receiving electric service and be a bona fide resident in the district that will be up for election. The candidate may not be employed by or financially interested in a competing enterprise or business selling electric energy or supplies to High Plains Power.

Equip in Advance of Emergencies

Be prepared for weather-related emergencies, including power outages.

- Keep an up-to-date emergency kit, including:

 Battery-operated devices, such as a flashlight, weather radio and lamps
 - Extra batteries
 - First-aid kit and extra medicine
 - Baby items
- Cat litter or sand for icy walkways
- Stock food that needs no cooking or refrigera-
- tion and water stored in clean containers
- Ensure your cell phone is fully charged

Take These Steps for Your Home

- Winterize your home
 - Install weather stripping, insulation, and storm windows.
 - Insulate water lines that run along exterior walls.
- Clean out gutters and repair roof leak
 Check your heating systems
- Check your heating system
 - Have your heating system serviced professionally to make sure that it is clean, working properly, and ventilated to the outside.
 - \circ $\,$ Inspect and clean fireplaces and chimneys.
 - Install a smoke detector. Test batteries monthly and replace them twice a year.
 - Have a safe alternate heating source and alternate fuels available.
 - Prevent carbon monoxide (CO) emergencies
 - Install a CO detector to alert you of

the presence of the deadly, odorless, colorless gas. Check batteries when you change your clocks in the fall and spring.

- Keep grills, camp stoves, and generators out of the house, basement and garage.
- Keep generators at least 20 feet from the house.
- Leave your home immediately if the CO detector sounds, and call 911.
- Learn symptoms of CO poisoning: headache, dizziness, weakness, upset stomach, vomiting, chest pain, and confusion.

Do This When You Plan to Travel

When planning travel, be aware of current and forecast weather conditions.

- Avoid traveling when the weather service has issued advisories.
- If you must travel, inform a friend or relative of your proposed route and expected time of arrival.
- Follow these safety rules if you become stranded in your car.
 - Make your car visible to rescuers. Tie a brightly colored cloth to the antenna, raise the hood of the car (if it is not snowing), and turn on the inside overhead lights (when your engine is running).

- Keep your body warm. Wrap your entire body, including your head, in extra clothing, blankets, or newspapers. Huddle with other people if you can.
- Stay awake and stay moving. You will be less vulnerable to cold-related health problems. As you sit, keep moving your arms and legs to improve circulation and stay warmer.
- Run the motor (and heater) for about 10 minutes per hour, opening one window slightly to let in air. Make sure that snow is not blocking the exhaust pipe – this will reduce the risk of carbon monoxide poisoning.

Above all, be ready to check on family and neighbors who are especially at risk from cold weather hazards: young children, older adults, and the chronically ill. If you have pets, bring them inside. If you cannot bring them inside, provide adequate, warm shelter and unfrozen water to drink. No one can stop the onset of winter. However, if you follow these suggestions, you will be ready.
