The Long Hours of Harvest Season

As we finish up the summer season, we know that long hours in the field are part of the job. We encourage everyone to be safe, be aware of the location of power poles in proximity to fields and equipment.

If you hit a pole or have a line down, call immediately before exiting the vehicle. It's always better to be safe than sorry. Our crews respond quickly and will make sure the lines are de-energized if necessary.

It is also a best practice to call before you dig - even in an area that you know well. Cable lines can still be buried right along an irrigation ditch. Underground lines can be where you least expect them. Save yourself time and trouble and call 811 before you dig.
